CT jumping at end of each equivalent HT division. *Proceed directly to XC start after SJ.*

1:30pm Cross-Country Jumping; run from highest down (Mod/Training to Green as Grass)

Awards:	HT: Ribbons to 8 th , prizes to 3 rd . CT: Ribbons to 8 th , prizes to 1 st . Dressage Tests: Ribbons to 5 th . The Hopeful is part of the <u>MiniEvent Triple Crown Series!</u> Check paradisecreek.ponyclub.org for info.
Rules:	Current USEF & USPC Rules for Eventing will be followed, though some latitude will be made for the unrecognized event. Ask organizer if you have specific questions.
Lead Riders:	Lead riders for cross-country are intended for the assistance of inexperienced riders (i.e. D1 and D2 level Pony Clubbers) in the Starter and Green as Grass divisions. Lead riders may or may not be available for all riders requesting them (bring your own?) we will do our best to provide a fun and safe experience for our new event riders! Leads are intended for green riders, <i>not green horses.</i>
Refunds & Pinneys:	Before the closing date, less \$15 (office fee). After closing date, less \$25, and only upon receipt of veterinarian or medical doctor's note. Non-returned pinney fee: \$25.
Starting Times:	Approximate start times available on-line Monday, June 21 st Final start times on grounds Friday, June 25 th at 2pm. Call (208) 877-1381. Check: paradisecreek.ponyclub.org
Directions & Terrain:	From the west; Deary, Idaho is 30 miles east of Moscow, ID on Highway 8. Pony Club grounds 3 miles east of Deary (on HWY 8) on the N side of the highway. Look for signs. Wooded, rolling hills.
Accommodations:	Camping on grounds, no hook-ups. Hotels available in Moscow, ID. One camping unit (fee) included with each stabling payment. Additional camping fee is \$10/unit per night.
Stabling:	We have upgraded! Nearly all stalls are 12x12 pole stalls (not covered) on grounds. \$20/night, or \$10 for daily haul-in (day stall may be available – check with secretary). Check in at office for stall assignments. Bedding not provided, and please only shavings (no straw) if bringing your own.
Concessions:	NOT available Please plan to bring your food – but check our website for updates closer to the event in case of last minute vendor options.
Other:	An interstate certificate of veterinary inspection (Health Certificate) is required for travel between Idaho, Oregon & Washington, as well as a current EIA (Coggins) test. Brand Inspections are HIGHLY recommended. <u>Please bring your horse paperwork with you to camp, but we are not requiring copies of them with your entry form.</u> NO VAPING, SMOKING, or MARIJUANA use on the grounds. Motorized vehicles only driven by licensed drivers, and not allowed on XC course or some signed areas.

**** Non-Pony Club Members: Must complete the USPC release form before riding on the grounds.**

All entry forms must be accompanied by a release of liability.

A parent or guardian must sign if the competitor is under 18 years of age.

RELEASE, ASSUMPTION OF RISK, WAIVER OF LIABILITY, AND INDEMNITY AGREEMENT
FOR USPC NON-MEMBERS

This document waives important legal rights. Read it carefully before signing.

I **AGREE** for myself, and/or my child, my/our administrators and assigns, in consideration for my, and/or my child's, participation in this United States Pony Clubs, Inc. (USPC) activity to the following:

I **AGREE** that I choose to participate voluntarily in an USPC activity, as a rider, driver, handler, lessee, owner, agent, spectator, volunteer, and/or trainer. I am fully aware and acknowledge that horse sports and USPC activities involve inherent dangerous risks of accident, loss, and serious bodily injury including, but not limited to, broken bones, head injuries, trauma, pain, suffering or death ("Harm"). I fully understand that this release covers, but is not limited to, inherent risks of an equine activity which mean a danger or condition that is an integral part of an equine activity, including but not limited to, any of the following:

- The propensity of an equine to behave in ways that may result in injury, death, or loss to persons on or around the equine;
- The unpredictability of an equine's reaction to sounds, sudden movement, unfamiliar objects, persons, or other animals;
- Hazards, including, but not limited to, surface or subsurface conditions;
- A collision with another equine, another animal, a person, or an object;
- The potential of an individual during an equine activity to act in a negligent manner that may contribute to injury, death, or loss to the person of the participant or to other persons, including but not limited to, failing to maintain control over an equine or failing to act within the ability of the participant.

I **Acknowledge** that it is my/parent/legal guardian responsibility to ensure that I am/my child is wearing a completed wristband or armband card at this USPC activity. I authorize USPC, its successors or assigns, officials, officers, directors, employees, agents and/or volunteers to obtain and release to any USPC activity personnel (including, but not limited to, organizers, instructors, test examiners, chaperones), and to any first aid and safety personnel, medical professional, and treating medical facility, any information regarding my/my child's medical history, symptoms, treatment, exam results and/or diagnosis contained in the wristband or armband card. Furthermore, I agree and understand that it is my/parental/legal guardian responsibility to ensure that I/my child will not participate in any USPC mounted activities if I/my child have/has had a head injury or other medical condition and have/has been restricted from activity, until such time as the injury or condition is resolved and any activity restriction is lifted.

I **AGREE** to release the USPC, its successors or assigns, officials, officers, directors, employees, agents, personnel, volunteers and affiliated organizations from all claims including, but not limited to, claims for money or property, disability, covenants, actions, suits, causes or action, obligations, debts, costs, expenses, attorneys' fees, judgments, orders and liabilities of whatsoever kind or nature in law, equity or otherwise, whether now known or unknown, suspected or unsuspected, and whether concealed or hidden, including but not limited to any state or federal statutory or common law claim or remedy of any kind whatsoever arising out of or in any way connected with any Harm to me or my horse and for any Harm caused by me or my horse to others, even if the Harm resulted, directly or indirectly, from the negligence of the USPC or the USPC activity.

I **AGREE** to expressly assume all risks of Harm to me or my horse, including Harm resulting from the negligence of the USPC or the USPC activity, and specifically agree to the applicable state statute/law regarding equine/farm animal activity liability and signed posting (if any), in any state in which I or my child participates in a USPC activity. While a list of state statutes and select portions of those statutes believed to be in effect at the time of the execution of this agreement is attached hereto, I **AGREE** to locate, review and understand the full applicable statute in place in my jurisdiction.

I **AGREE** to indemnify (that is, to pay any losses, damages, or costs incurred by) the USPC and the USPC activity and to hold them harmless with respect to claims for Harm to me or my horse, and for claims made by others for any Harm caused by me or my horse in the USPC activity.

I **AGREE** that neither I, nor any one claiming through me, will hereafter bring, commence, prosecute or maintain, or cause or permit to be brought, commenced, prosecuted or maintained, any suit or action, either at law or in equity, in any court in the United States or in any state thereof, or elsewhere, against the USPC, its successors or assigns, for, on account of, arising out of, or in any way connected with any Harm to me or my horse, and that neither I, nor any one claiming through me, will enforce, prosecute, or recover upon, or attempt to enforce, prosecute, or recover upon, any claim or right of action whatsoever, which I, or any one claiming through me, may now have or hereafter assert, in any way connected with claims for Harm to me or my horse, and for claims made by others for any Harms caused by me or my horse at the USPC activity.

I **AGREE** this Agreement is the entire agreement of the parties, and supersedes all prior oral and written understandings and agreements. This Agreement may be modified only by a written amendment signed by both parties.

I **AGREE** that if any provision of the Agreement is found to be invalid or illegal by a court of competent jurisdiction, the remaining provisions shall be construed as if the affected provision had not been included in order to effectuate the intent of the parties.

In the event this form is signed by the parent/guardian of a minor, then all representations and acknowledgements herein are expressly made by, for, and on behalf of the parent/guardian and minor.

By signing below, I **AGREE** to be bound by all applicable USPC rules and all terms and provisions of the USPC activity. I acknowledge that I enter into this release after having read the same, and place my signature hereto of my own free voluntary act and deed. By signing below, I represent to the USPC that I fully understand its contents that I do not need any further explanation, and I waive any further explanation.
